The First Presbyterian Church of Forest Hills Minutes of the Annual Meeting of the Congregation and Corporation February 11, 2018

The Annual Meeting was held in the church hall of the First Presbyterian Church of Forest Hills after the Sunday worship service. Adequate notification of this meeting had been provided in accordance with the Book of Order guidelines and our bylaws.

The meeting was called to order at 12:25 PM and opened with prayer by Moderator Rev. Jack Lohr.

A quorum of 30 members in good standing was established.

Non-members present in this meeting were acknowledged and their full participation was encouraged with the exception of the right to vote.

Necrology report: None

The <u>Minutes</u> from last year's Annual Meeting (previously approved by the Session), the present <u>Agenda</u>, as well as all prepared reports were approved by the congregation. All reports, including the Treasurer's, had been made available in advance for the congregation's review. The congregation was encouraged to ask questions or give their comments to the presented material. Elder Karl Stayna commended Leon Collier (our Treasurer) for his outstanding work on the budget.

Nadina Grants (Clerk of Session) invited Leon Collier to the floor in order to comment on his report.

Finances

Leon Collier informed the congregation that pledges for 2018 have increased by 9% from the previous year. For the past 3 years our deficit has been over \$100,000, but for 2018 it is projected to be reduced to \$74,000. Leon commented that our budget is in good shape. There were no questions from congregants in regard to Leon's report.

Roger Herr, our investment agent, was invited to the floor. Roger stated that the overall return on our portfolio has been about 9%. The market has been steady and reflects a positive economic growth. Roger said that few changes have been made to the securities owned and our investment account allows for flexibility should a need for changes arise in the future. The congregation thanked Roger and Leon for their diligent work.

Pastor Jack Lohr addressed the congregation regarding the Session's vote to renew his 12 month contract for the year 2018. Pastor Jack removed himself from the meeting in order to allow the congregants to evaluate his ministry among themselves. A lively response followed. Many voiced appreciation for the way our pastor has challenged us through his preaching, his insistence to think and love beyond our own walls, his love for all people, his interest in diversity of people, faiths, music, justice in our communities and the world. One congregant mentioned that we at times have lacked supporting our Pastor when he did invite us to get involved beyond our own "church" concerns. Another church member talked about exploring new ways to invite people into our church community. With all that was said, it has become clear how much our pastor's ministry has impacted our life together as a church community and beyond. At 1:15 PM, Pastor Jack was asked to rejoin the meeting and he was greeted by his grateful congregation.

Michelle Loeb, chair of Deacons, spoke briefly about the blessings she had received while serving on the board. Michelle thanked all the deacons, who have worked faithfully throughout the year.

Nominating Committee Report

The nominating committee was unable to complete the task by filling all upcoming vacancies.

For Session:

Nominated for the class of 2020 were Michelle Loeb, JJ Marasigan, Jessica Odle-Baril, and Jang Tessalee who agreed to serve. Two vacancies remained. The floor was opened to the congregation to receive nominees for Session. Two nominees declined. Since there were no other nominations forthcoming, a motion was made and carried to close the nomination from the floor.

Stated Clerk looks to challenges, opportunities facing the church in 2019

January 2, 2019 by Rick Jones, Office of the General Assembly For 2½ years, the Rev. Dr. J. Herbert Nelson, II, has listened to the heartbeat of the church. The Stated Clerk of the PC (U.S.A.) has been on the road for most of his tenure, meeting with presbytery and synod leaders and listening and worshiping with churches facing difficult times.

Nelson says one of the challenges is the continued need to lift the spirits of those who have been through trauma over the past 30 years in the life of the denomination. "Congregations that are representative of splits from larger congregations that existed and the struggles that we've had in becoming an all-inclusive church are among those challenges. There have

also been struggles in addressing or not addressing some of the contextual realities that we are dealing with in the world."

Nelson says the political atmosphere has impacted everyone. "I don't think all of us are wholly conservative, liberal or moderate. I believe we are free thinkers who have an ability to do great things when we allow our minds to be expanded. And yet these categories, even in the life in the church, have caused us to categorize ourselves. Interestingly, Jesus doesn't mention any of that in the Bible and does not carry those labels."

As membership declines in some churches, congregations are searching for direction, says Nelson. "We see families in the denomination who are split and in different churches. The way in which we resolve these internal struggles is going to be a continued emphasis in the life of this denomination," he said. "The quicker we learn how to resolve that and be the community that we are, rather than lamenting over what we used to be, will have a great deal to do with how we are projecting our future."

Nelson also says the church needs to be recharged. "I don't believe we are a poor church. I believe we still are a church of wealth. A few studies make it clear we have an enormous amount of money within the denomination," said Nelson. "I do believe the self-image of the PC(USA) is now challenged in how we see ourselves. We have a lot, but we see ourselves in a much smaller picture because of what we've been through and the decline we've faced over the years."

Nelson says he finds churches asking what to do now. "We are not the church we used to be and not necessarily in the same community we used to be," he said. "We are an aging church and younger people are not in church as they once were, and we don't know how to get them here. What we need to do as older people is to try and help them be part of the church."

According to Nelson, the church must learn to talk about Jesus and speak to the authority of the scriptures and faith. "As Presbyterians, we can no longer sit back and not have a faith that speaks of Jesus and speaks to the power of Jesus in our own lives. We can't sit back and refuse to tell our stories of what our faith has done for us because somehow, we've framed that as private. Our faith is not private, it is very public. And Jesus had a public ministry not a private ministry. If we're modeling the behavior of the one we follow, we too have to be about the business of publicly expressing who we are in Jesus Christ."

Nelson says the PC(USA) has attempted to model that at the national level around faith, justice and contextual issues. "We are putting scripture, rationale with regards to faith in Jesus Christ, and the Old Testament prophets to give declaration to fact that this is biblically grounded, and it is a part of who we are as a people called Presbyterians, not just something we read and adopt in our own language," he said. "This is our Lord and Savior and we are going to have to learn how to talk about Jesus again."


2018 – A Year in Religious News (Religion News Service)

A year ago Bill Hybels was the well-respected pastor of one of the most influential megachurches in the nation. Theodore McCarrick was a prince of the Catholic Church, and Michael Curry was the relatively unknown head of a mainline Protestant denomination. What a difference a year makes.

In April, Hybels stepped down from Willow Creek Community Church after being accused of years of sexual harassment and misconduct. Hybels denied the allegations. But the suburban Chicago church — after initially defending him — called his behavior sinful. Eventually, Hybels' successors and all the church's elders resigned, leaving the church with a \$3.3 million budget deficit and an uncertain future.

In July, McCarrick was forced to resign from the College of Cardinals and was ordered by Pope Francis to lead a "life of prayer and penance" after being accused of sexually assaulting a minor four decades ago. McCarrick was also accused of sexually harassing seminarians for years.

Meanwhile, Curry skyrocketed to international fame after nearly 2 billion people tuned in to a royal wedding and heard his sermon, "The Power of Love." "I'm talking about power," he said as Prince Harry and Duchess Meghan Markle — and a global audience — listened. "Real power. Power to change the world." That sermon made Curry perhaps the best-known Protestant clergyman on the planet and earned him



recognition as the "Religion Newsmaker of the Year," according to the Religion News Association. The popularity of Curry's sermon was a testament to the enduring power of religion in a year full of tumult in the world of faith, as it was elsewhere.

Catholics across the country were shaken by the release of a scathing report from a Pennsylvania grand jury, detailing the abuse of more 1,000 children by 301 priests in six dioceses over 70 years. That report reignited the church's long-running abuse scandal and led dioceses across the country to open their files and reveal the names of priests accused of abuse.

Protestant churches and other religious groups also dealt with sexual harassment and abuse scandals in 2018 as survivors of abuse and harassment spoke out against powerful religious leaders. Among them was Jules Woodson, who confronted Memphis, Tenn., megachurch teaching pastor Andy Savage in an email about an incident that occurred in the late 1990s, when he was a youth pastor and she was a teenager. Woodson claimed Savage sexually assaulted her, while he claimed their relationship was consensual. When he penitently confessed at a Sunday service in January, the congregation gave Savage a standing ovation, sparking outrage. He later resigned, followed by the church's teaching pastor.

Rachael Denhollander, a former gymnast whose testimony helped convict former USA Gymnastics team doctor Larry Nassar for decades of abuse, said her faith caused her to both confront and forgive her abuser. Nassar eventually was sentenced to up to 175 years in prison. "I pray you experience the soul-crushing weight of guilt," she told Nassar, "so you may someday experience true repentance and true forgiveness from God, which you need far more than forgiveness from me — though I extend that to you as well."

The past year also saw a wave of religious-linked violence and repression around the world. In Yemen, a war between rebels backed by Shiite Muslim leaders in Iran and the government backed by the Sunni government of Iraq led to one of the world's worst humanitarian crises.

A deadly attack on the Tree of Life synagogue in Pittsburgh in October left 11 worshippers dead. The mass shooting, deemed the deadliest anti-Semitic attack in U.S. history, came amid a growing wave of anti-Semitism in the United States and Europe.

In China, as many as a million Uighurs, members of a mostly Muslim minority group, have been rounded up and detained in secret internment camps, labeled "vocational training centers." Chinese officials have been accused of trying to erase the Uighurs' culture and religion.

Among the other top stories from 2018:

Billy Graham, famed evangelical preacher and spiritual adviser to U.S. presidents, died at 99. His evangelistic crusades filled stadiums around the globe for decades, and even in retirement, he remained one of the most admired people in America.

The U.S. Supreme Court ruled that the so-called "Muslim ban," which bars travel from a number of Muslim-majority countries, is legal. The ban is part of a larger Trump administration policy to limit the number of refugees and immigrants allowed into the U.S. The Supreme Court also sided with Jack Phillips, a Colorado baker who refused to make a wedding cake for a same-sex couple. The court ruled that Colorado officials discriminated against Phillips based on religion. But the decision did not end Phillips' legal woes: He recently appeared in court again in another discrimination case.

Religious leaders helped lead opposition to a Trump administration family separation policy at the border.



During the 2018 midterm elections, Ilhan Omar and Rashida Tlaib became the first Muslim women elected to Congress.

A Turkish judge freed Andrew Brunson, an American pastor who had been jailed for two years after being accused of being a spy and conspiring against the Turkish government.

Asia Bibi, a Pakistani woman sentenced to death for blasphemy, was freed after Pakistan's highest

court threw out her conviction. Her acquittal led to riots and calls for her death. She remains in hiding.

American missionary John Allen Chau was killed while trying to contact an indigenous people group on North Sentinel Island in the Bay of Bengal. Indian officials said Chau's attempt to contact the Sentinelese was illegal. Critics of Chau said he was misguided, while supporters called him a martyr.

Commemorations of the 50th anniversary of the death of the Rev. Martin Luther King Jr. led to renewed calls to address the ongoing legacy of racism in the U.S. During one event, held by Southern Baptists and other conservative groups in Memphis, news broke that a white Baptist church was expelled from its local association for racism. That church eventually became the first church removed from the Southern Baptist Convention for racism.

James Cone, a famed theologian known as the founder of black liberation theology, died at 79. Eugene Peterson, whose Bible paraphrase "The Message" sold millions of copies, died at 85. Known as a pastor to pastors, Peterson was an author, theologian and preacher. Among his last words were "Let's go."

EASTER SUNDAY CELEBRATION!

"Dear friends, now we are children of God, and what we will be has not yet been made known.

But we know that when Christ appears, we shall be like him, for we shall see him as he is." –1 John 3:2

My theme for the year was "Preparing for God's Future." As I led in worship and teaching and pastoring and standing for justice, I tried to be a model for what our church already is becoming. As we say in our mission statement, we are called "to welcome all people into our diverse family of Christian faith and fellowship, to experience and celebrate God's presence in worship and daily living, to share the love of Christ by reaching out to those in need, and to proclaim by word and deed the message of God's love and the Gospel of Jesus Christ our Lord and Savior." And we are doing it.

Our "Immigrants and Refugees Welcome" banner continued to speak for us and draw in people who share that vision. At the end of the year, we also got an angry reaction from someone who cut down our banner! Whether visitors seeking help, supporters joining us in ministry and fundraising, or times of taking a stand, we were part of a community that cares about all of our neighbors!

Following the mass shooting at Marjory Stoneman Douglas High School in Florida, we instituted a solemn reading each week's gun deaths, and many of us joined the "March for Our Lives" in Manhattan on March 24. The annual Pancake Breakfast (thanks, men!) and Egg Hunt (thank you, Janice) got our Easter started off with joy!

We participated in many interfaith activities in 2018, including a discussion of our beliefs here at FPCFH in January, Interfaith Passover Seder at Central Queens Y (now known as Commonpoint Queens), Sukkoth Dinner and Community Thanksgiving Service at Reform Temple of Forest Hills, and "Show Up for Shabbat" at the Forest Hills Jewish Center.

During the year, we said farewell to Rev. Akimitsu Nishikawa and the Japanese Fellowship of Queens as the church ceased worship and the pastor returned to Japan. We also bid farewell to Fr. Nazaret Ricarte and the Iglesia del Divino Niño y Nuestra Señora de Guadalupe as that group was

reincorporated into the Apostolic Catholic Church of the US. We still share space with 2 PC(USA) congregations: the Woori Faith Presbyterian Church (led in worship in Korean by Rev. Won Tae Cho on Sunday at 8 AM) and the Thai Community Church of NY (led by Pastor

Jang Tessalee in Thai Sunday at 2:30 PM).

The Lohrs hosted our third (and, since we've moved to NJ, our last) Epiphany Open House at the manse. It gave us a chance to welcome the congregation into our home, with the help of our daughter Rebeca (who was living with us until her move to Zurich).

During Lent, our Wednesday covered dish suppers did a book study with Rob Bell's Love Wins.

Through the first half of the year, we continued the ministry of Seminary Intern Audrey Webber, who joined in the planning and leading of worship, involvement with the Adult Bible Class, and coleading the Confirmation Class (including chaperoning the Confirmation Retreat!). Her energy, creativity, imagination and love were a true blessing in the life of the church! On Pentecost, we

welcomed Nevaeh Mitzner, Brianne Raymond, and Isaac Strong as members of the church.

This year, I was able to take part in our VBS, "Rolling River Rampage." What energy! What fun!

My ministry outside the congregation included leading worship once a month with residents at Fairview Rehab and Nursing Facility in Forest



Hills, and several times at my father-in-law's place in Wyckoff, NJ. I participated in programs of the New Sanctuary Coalition of NYC. Occasionally I joined the Monday Insight Meditation Society group at FPCFH. I continued my involvement with Faith in New York (until they went on hiatus).

Ushers greet everyone coming in to the church especially on Sunday mornings and there is always an air of warmth and joy as people interact with each other before, during, and after services.

We were blessed to have seminarian Audrey Webber participating in the planning and leadership of worship during the first half of the year. She also preached twice – April 8th (Holy Humor Sunday) and May 6th (Use Your Gifts)– and showed us how much promise she had as a budding young pastor-to-be. She will be graduating this May and is also expecting her first child soon! Congratulations to both her and Woodie and their families!

The congregation also stepped in to take charge of worship while Pastor Jack was away. Nadina Grants preached on "Jesus, the Bread of Life," on August 5th. JJ Marasigan preached on "Hope as a Theological Virtue" on Aug 12th, and Michelle Loeb led us in worship on Nov 4th while Jack was at his mother's bedside.

As is customary in our church, we also had our stewardship talks and we were blessed to have David Barnett, Lois Anne DeLong, Tanessa Cabe, Charlie Potter, and Anna Strong talk to us about what this church meant to them personally.

We also had visitors from the Cornerstone Theater Company and representatives of the Coalition of Immokalee Workers.

To honor the victims of shootings across the United States, Pastor Jack, with the help of the members, read out each week the names of the victims. This brought focus to a critical issue which our country is struggling with even today.

In the Fall, a few of our members showed up Shabbat service at the Forest Hills Jewish Center after the mass shooting at the Tree of Life Synagogue in Pittsburgh. Pastor Jack also offered the Thanksgiving sermon at the Reform Temple next door, as is our usual custom, and Rabbi Mark Kaiserman came to offer us a sermon, too.

Music ministry at our church has also added to the worship at First Presbyterian Church of Forest Hills. It started strong during the year and initially helped with Sunday worship music when David Yurick, the Choir Director and Organist, was away. Over time, the team has now become a permanent fixture every Sunday for worship and plays alongside David Yurick. TIME WITH CHILDREN

Christian Education & Nurture

"Thy word is a lamp unto my feet, and a light unto my path,"
---Psalm 119:105

Providing opportunities for young and old alike to grow in understanding and wisdom is a core mission of our church. Here are the ways our Christian Education Committee served as light bearers in 2018.

Sunday School

Our Sunday School currently has about six students, divided into two age groups: pre-school age to 2nd grade (early elementary), and elementary to middle school (3rd grade-8th grade). Pat Young teaches the young ones, while Karen Wood teaches the older grades.

For the first half of the year, the childrens' lessons were drawn from "Deep Blue Kids," a curriculum developed by the United Methodist Publishing House that integrates Sunday School lessons with home activities, and, for a while, the Bible texts used in worship. Since September, we have switched to David C. Cook's Bible-in-Life curriculum. The switch was made because our Sunday School leaders thought its approach was more effective in teaching the children to better understand the Bible.

The Sunday School children not only receive lessons, but share them as well. During the Time with the Children portion of morning worship, their insights and observations often teach the idea better than any adult could.

Adult Bible Study

The Adult Bible Study class has been well attended over the past year. The class has a core group of about five people that come every week, while another 3 or 4 individuals attend at least two times a month.

The focus of our studies has changed over the course of the year. Though earlier studies were more "book driven," that is involving discussion of popular works exploring aspects of faith, the group decided it wanted to instead directly tackle the scriptures. As such, the short-term studies over the past year have included:

Rob Bell's book: 'Love Wins' (Lenten study)

Peter Rollins: 'The Idolatry of God"

The book of Romans
The book of Ephesians

A look at the stories of Advent in the Gospels

We are now embarking on a seven-part study of the book of Acts, guided by study materials and questions from the Thomas Nelson, Inc. publishing company. We plan to begin a Bible study tied to the season of Lent beginning on March 10.

All are welcome to join us in Room 7 every Sunday at 10 a.m. through the end of June.

Confirmation Class

On May 20.we welcomed three of our Sunday School youth—Brianne Raymond, Nevaeh Mitzner, and Isaac Strong—into membership through the act of confirmation. The three young people completed a confirmation class, lead by Jack Lohr and our seminary intern Audrey Webber. Among the special activities during this period, the youth ran a bake sale to help pay for a Confirmation Retreat at Holmes.

Vacation Bible School--Riding the River of God's Grace

From July 9-14, our church hosted its annual Vacation Bible School. The theme this year was "Rolling River Rampage," and was built around the message of Isaiah 43:2: "When you pass through the waters, I will be with you."

Images, activities, and songs revolving around rafting and water adventure were the back drop for a week of crafts, games, science activities, music, and Bible skits. As Pastor Jack stated in his blog about the



school, "Fourteen children and youth, and eight adults are in the boat/raft together, learning through Bible stories, songs, crafts, science, puppet shows with 'Romper' the river otter, delicious lunch and snacks... and just plain fun!

Vacation Bible School, 2018

Mission Committee

"Consequently, you are no longer foreigners and strangers, but fellow citizens with God's people and also members of his household." ---Ephesians 2:19

The idea of seeing "foreigners" and "strangers" as "fellow citizens," could serve as a theme for the work of our committee this past year. While our work with the Interfaith Immigrant Action Coalition on behalf of refugees and the undocumented may be the most obvious example of this theme, we also acknowledged a "shared citizenship" with those impacted by natural disasters and hunger, the peacemakers in communities around the world, and all those who call for an end to gun violence.

Here are a few of the outreach initiatives conducted by the church in 2018. Though not all the activities below were organized by the Mission Committee, I include them all here to offer a true picture of this church's commitment to living out the hopeful message promised in the Gospels.

- We marched with 200,000 other New Yorkers in the March for Our Lives to call for common sense gun legislation.
- We joined with our Muslim, Jewish, and Christian brothers and sisters at worship services at the Forest Hills Jewish Center to mourn the murders at the Tree of Life synagogue.
- We brought one of our overseas mission partners, Kurt Esslinger, to New York to meet with us and to speak at a Presbytery-sponsored event about his work for reconciliation between North and South Korea.
- We raised \$1,145.83 for One Great Hour of Sharing.

- We introduced another PCUSA offering— the Peace and Global Witness offering and raised \$225 for this cause.
- Through the Interfaith Immigrant Action Coalition, we sponsored two events to raise awareness
 and funds for two groups that support immigrants and refugees—No More Deaths and the
 International Rescue Committee. The second of these events (the first was geared more towards
 raising awareness of the group and seeking support for the larger event in the fall) raised a total of
 \$1,574.00, which was equally divided between the two groups (A shout-out here to Bruno and all
 the musicians who helped make the "Together we Stand" event so wonderful.)
- We provided a venue for an open discussion about the movement to close Rikers Island.
- We set up a letter writing campaign to oppose the proposed changes to the definition of "Public Charge," which could endanger the eligibility status of immigrants.
- We collected food for Thanksgiving at Forestdale, and Christmas toys for 20 children under the care of Hour Children.
- We collected school supplies, including notebooks, paper, and folders for the children of families assisted by the International Rescue Committee.
- We regularly collect food for a local food pantry, and participated in a one-day community Food
 Drive outside Key Food on Queens Boulevard (special thanks to Michelle, John, and the others
 who make the Food Drive happen every year).
- We brought our "songfest" to Forest View Center, a rehabilitation and residential health care center, three times in 218, including a December holiday celebration in which we were able to share songs, joy, and warm socks. Thanks to Ingrid and to all those who donanted socks, as well as our musicians and singers.
- We continued our support of a 10-year old Salvadoran child named Estephany, who we adopted through World Vision. This year we sent a small extra donation so she could have a birthday party in her community.

In addition to the above, our committee continued its support of a handful of local nonprofit groups, and four PCUSA mission personnel. This past year, each of these groups/individuals received a donation from the church of \$1,500. We will continue to financially support most of the names on this list, and to promote their mission and any opportunities for volunteer participation in 2019 as well.

Hour Children: (http://hourchildren.org/) based in Long Island City, this group ministers to the children and families of incarcerated women, helping the women with job and life skills, housing, and counseling, and the children with daycare, after school programs, and recreational activities. The recidivism rate, or percent of participants that end up back in jail, for women in this program is 3.5%, compared to an average rate for New York state of 39.9%.

Not So Churchy: (http://www.notsochurchy.org/) a worshipping community, currently meeting at Congregation Beit Simchat Torah in Manhattan. that welcomes those for whom church is often not so welcoming: members of the LGBTQ community. Not So Churchy, according to its website is about forming community that is "intimate, portable, and spiritually curious and committed."

ShareTheCaregiving, **Inc**: (https://sharethecare.org/) The parent organization of the successful shared service group that assists individuals within and outside our church. The Manhattan-based group cites as

its mission "To improve the "quality of life" of anyone who needs support—and to reduce the stress, depression, isolation and economic hardship of their caregivers."

Forestdale: (http://www.forestdaleinc.org/) Helping families in Forest Hills and the borough of Queens since 1941, this foster care/adoption agency attempts to address "the underlying causes of the underlying causes of families in crisis. Forestdale offers a wide range of services, including parenting classes and youth activities.

Women for Afghan Women: (https://www.womenforafghanwomen.org/) a "grassroots, civil society organization; our mission is dedicated to securing and protecting the rights of disenfranchised Afghan women and girls in Afghanistan and New York, particularly their rights to develop their individual potential, to self-determination, and to be represented in all areas of life: political, social, cultural and economic."

The nominating Committee recommends (in compliance with the church bylaws, 6.A) that the number of Deacons for 2019 be set at nine.

Investment Account Report

Beginning Value (1/01/18) \$1,494,434 Ending Value (12/31/18) \$1,434,982 Change in Account \$ 60,568

Total Church withdrawals from the Investment Account were \$120,000 in 2018 (up from \$51,000 in 2016 and \$95,000 in 2017). The account was only down \$59,500 at year end --which means the account generated a 4% return (as reflected in the \$60,568 Change in Account shown on the December statement) to offset the withdrawals.

The account continues to be structured to provide meaningful income in a relatively low interest rate environment. The portfolio generated income and distributions of \$39,500.

The expected volatility mentioned in last year's report finally showed up in the significant market selloff experienced last December. Given that approximately 30% of the investment account is in cash or short term treasuries, the Church weathered the storm well. Furthermore, I am pleased to report that as of today (1/31), the Investment Account now stands 9 1/2% higher than at year end 2018.

Note: The above report does not include the separate "Building Fund" account. This cash account started the year at \$124,645 and ended at \$64,107. Checks totaling \$61,215 were written against this account.

In closing, it should be noted that a total of \$184,107 of Church expenditures were financed from the Endowment. (Praise the Lord).

First Presbyterian Church of Forest Hill Treasurer's Report to the Congregation Financial Operating Results for the Year 2018

Summary Overview

First Presbyterian Church of Forest Hill (FPCFH) financial results reflected a stable performance for the year and one with which the Congregation should be rightly proud. For the second year in a row, pledged revenue exceeded the budgeted amount. 2018 total operating revenue were \$331,852 under the budgeted amount \$351,454 by \$19,602, or 6%. As a result, the church ended the year with an operating deficit (-\$103,178) or 42% over budget.

Revenues

In the operating account we received \$89,586 of pledges which was 125.4% of the total budgeted. Total receipts of \$331,852 equaled 94.4% of budget. Receipts were \$19,602 less than the budgeted amount because nursery school tuition income of \$124,209 was\$16,791 less than budgeted. Nursery School is a matter of some concern, although no single fact explains this performance.

Loose Plate were favorable to budget by \$1,309, or 24%. Interest Income of \$40,125 came in right on the budget as expected, Rental Income \$43,280 were favorable to budget by \$680 or 2%.

Expenses

Operating disbursements were \$435,030, or 102.5% of the budgeted total. We ended the year with a disbursement balance of \$435,030 over receipt of \$331,852 resulting in a year-end deficit of (\$103,178).

Minister's account came in very close to budget as expected. The Lay Employees account was essentially on budget, with minor pluses-minuses in each line item. (1) Christian Education came in substantially under budget with expenses less than expected in all the program areas. (2) The Church Office Expenses came in about 10% over budget. (3) The Church Utilities came in 37% over budget and (4) Repairs and Maintenance on Property accounts came in substantially over budget. Due to the following additional costs:

FPCFH's Capital (Building and Grounds)

The building and Ground Team oversees the maintenance and care of the church facility, the grounds, other church property (church manse). The Team worked hard to hold our expenses to the budget. The annual budget and the long-term capital budget are a large portion of what we do. With the Ken Koward's fund help us try to control operations to meet those goals.

Capital Expenditures for 2018:

During 2018 we were able to perform several capital projects to keep our buildings and grounds in terrific shape.

- Setup containment's and critical barriers around the boiler room; including a 3-stage decontamination chamber with pop up shower.
- Setup and utilize proper negative air pressure for use during abatement and until air clearance are received.
- Remove 40 if of asbestos pipe wrap insulation clean and encapsulate pipes
- Remove all asbestos contains debris to a certified landfill and create manifest
- Replace oil boil with new gas boiler and water heater
- New Doors and Locks to the sanctuary and Fellowship.

Thus, the entire building has good heating and cooling which should require minimal repair costs for several years.

We have invested in a Cash, Bank Deposit Program and Money Market Funds portfolio with yearend value of \$1,434,982. The current Cash balance is \$175,545, Equities totals \$738,662, Fixed Income & Preferred total \$309,260 and Alternatives total \$211,515.

Finally, the Budget for 2019 is presented. The Session has approved it and is awaiting a vote by the Congregation members to adopt it at the annual meeting. The 2019 budget is based on 2018 actual figures which can be seen next to the 2018 budget figures. It includes estimates for 2019 Sexton expenses since we are searching for a sexton.

This year was financially challenging for the Church's and each year continues to be as difficult to balance the books. The budget presented and approved by the Session shows a deficit of nearly (\$60,488) assuming pledges remains flat with the 2018 budget.

We are fortunate to have the Investment fund, and if we continue to have economic recovery and market stability, we should be able to use some of the earning interest in the future. We should rely on our Pledge Income to provide most funds for worship, program and activities.

Year-End Deficit:

The net deficit of (\$17,996) was unfavorable to the budget by \$12,654 for the month of December and the end of year net deficit of (\$103,178) was unfavorable to the budget by (\$30,291).

Remainder of the Financial Report



I would now like to review with you our 2019 operating budget. The budget reflects the costs of providing unparalleled pastoral care, learning, services, events and programming for our diverse demographic base, as well as the sources of funding these costs.


2019 Budget Income \$341,522



As you can see in the Income pie chart above, membership dues, although a significant commitment on all our parts, covers only about 25% of FPCFH operating budget income while income from nursey school and interest income accounts for another 48% of the total. The other income categories cover 27% of the operating income.


The last source of income building rental is expected to generate a third of FPCFH 2019 income. Ideally, we would aim to have a larger percentage of our operating income come from pledge donations and to allocate more of our building rental income for capital improvements and investment reserves, Investment account amount to \$1.5 million at year-ended 2018.


The Expenses pie chart below indicates that church Building and Grounds costs (utilities, maintenance and service, repairs, etc.) represent 19% of total expenses. Administrative and Office expense represent 51% of expenses.




Church Operating Revenue for 2018

The Church operating revenue for 2018 totaled \$331,852. Pledge offering, Presbyterian foundation, investment interest, rental income and nursery school tuition fees made up more than 89% of the revenue. Total tuition fees were \$124,209. See chart below.






With the goal of cutting expenses where possible and increasing income, we are hoping with your help to build up our interest income reserves. Looking forward, we would be grateful for your participation in coming up with new ideas on these fronts. Until such time as our interest income reserves are adequate, we are heavily dependent on prompt payment of dues and pledges in order to continue to offer the quality program offering and to support our seasonal cash flow.



Since 2016, our income annual growth rate has been 4%. The fastest growing sources of income have been Special Contribution (5%), Pledge Income (6%), and Rental Income (10).



Since 2016, the Building and Ground (Church Property) expense line have grown at an average annual rate of 6% and the Nursery School expenditures have grown at an average annual rate of 4%. With the goal of cutting expenses where possible and increasing income, we are hoping with your help to
